While the priority of policy is to prevent youth unemployment and insecure employment, European countries still face the challenge that many young people suffer from unemployment or have insecure jobs. The EXCEPT project identified policies that mitigate the negative consequences of unemployment and job insecurity with regard to health, well-being and autonomy.
